History

- 1948** Old Age and Survivors' Insurance (AHV) is introduced in Switzerland. «AHV Wirte», the landlord compensation fund for old age and survivors' insurance, is set up by the Swiss landlords' association (Schweizer Wirteverband).
- 1974** «BAV Wirte», a foundation providing employee benefits insurance, is set up by Schweizer Wirteverband.
- 1982** The collective labour agreement makes employee benefits insurance mandatory in the hotel and catering industry. The Federal Law on Occupational Retirement, Survivors' and Disability Pension Plans (BVG) follows three years later.
- 1996** The compensation fund is renamed «AHV GastroSuisse» and the pension fund renamed «BAV GastroSuisse».
- 2005** After an organisational merger, the compensation fund and pension fund take the name «GastroSocial».
- 2016** The company moves into the modern GastroSocial Tower in Aarau.
